



Can Swiss organisations participate in European funding programmes in 2025? Since January 2025, Swiss organisations can once again participate in European funding programmes as beneficiaries. Horizon Europe, including Eurostars, EIC Pathfinder and DIGITAL Europe, offers benefits for SMEs, start-ups and industry. Will Swiss companies be able to participate in Horizon Europe? After years of uncertainty, Switzerland is once again fully associated with Horizon Europe and other EU research and innovation funding programmes as of 1 January 2025. Although the formal process is still underway, the outlook is promising: Swiss companies will be able to participate in Horizon Europe on equal terms. Will the Swiss accelerator issue new calls for proposals in 2025? In light of Switzerland's likely association in 2025, the Swiss Accelerator will no longer issue new calls for proposals, as Swiss SMEs will once again be eligible to apply directly to the EIC Accelerator. Who participates in R&D projects in Switzerland? Over the past few years, many Swiss SMEs (small and medium-sized enterprises, including start-ups) and industrial players (large companies, including multinational corporations) have participated in European and nationally funded R&D projects. How much money was invested in Swiss startups in 2024? EY's analysis of Swiss startup funding reveals trends in region, gender and industry, and explores financing for startups using AI. Download the EY Startup Barometer Switzerland In brief CHF 2.3bn was invested in Swiss startups in 2024 but the number of funding rounds and the invested volume have declined for the second consecutive year. Which sectors are most financed by Swiss startups in 2024? As in the previous year, startups in the health sector (biotech, medtech, care, life sciences, digital health, fitness, beauty) claimed the largest share of total financing in 2024, securing approximately CHF 1.0 billion, or 45% of all funds invested in Swiss startups.
