How is public procurement regulated in Switzerland? The Swiss Confederation and the 26 cantons each have the power to enact their own public procurement legislation for public procurements by entities on a national and cantonal/municipal level within the framework provided by international and national law. Thus, public procurement in Switzerland is regulated on three levels: How does a cost-covering fee affect electricity production in Switzerland?
