



# government procurement price of business energy storage in Tanzania

Do firms participate in Zanzibar energy sector support project tenders? This is based on information obtained from ZECO (Annex 1) which shows considerable level of participation of firms in the tenders floated in under Zanzibar Energy Sector Support Project financed by Sweden. Is corruption in procurement a serious problem in Zanzibar? However, reports obtained from the Zanzibar Anti-Corruption and Economic Crimes Authority (ZAECA), shows that corruption in procurement and contract management is not a very serious problem. Of all cases of corruption reported to ZAECA for , only 2.6% related to procurement and contract management<sup>3</sup>. Why does ZECO have a limit time to purchase tender document? Currently ZECO has set limit time to purchase tender document this has rectifies the said challenges. Some bidders' appeals to the public procurement authority but always ZECO come out with positive outcome because it always adhered to compliance with procurement regulations. How does ZECO secure the procurement process? To be safe within the procurement process from submission of tender document to the awarding period, bidders are requested by ZECO to secure the process by submitting the bid security. Any default (such as refuse to sign the contract, withdrawal from the procurement process) by bidder within the process period the security will be used against him. What is a Procurement Management Unit (PMU)?

### 2.2.3 ZECO Procurement Cycle.

The Procurement Management Unit (PMU) is responsible to manage all procurements or disposal activities of ZECO except adjudication and the award of contracts. How can ZECO reduce residual risk in the procurement process? ZECO on its part should be able to identify, evaluate how risks will be managed at different stages of procurement process to minimize adverse impact to the procurement approach and objectives. With mitigation measures put in place, the residual risk is expected to reduce substantially. The ongoing grid optimization study has identified the feasibility of up to 40MWh of battery storage, as a part of the least cost supply expansion. The estimated cost of BESS is USD 17 Million.
