What is the energy storage project in Belgium? The main energy storage project in Belgium is the construction and operation of an offshore "energy atoll" (essentially a manmade offshore pumped-storage facility), for which the Electricity Act has been modified in (see below), in order to support offshore wind-generated electricity production. What funding is available for R& I projects in Belgium? Belgium: Energy Transition Fund. Support for R& I projects for energy. The funding for energy related R& I projects in amounts to 25 million EUR. Who manages a distribution grid? The distribution grid operators (DSO): They manage mid-voltage grids (10 to 70 kV) and the distribution grid. The energy suppliers: They supply power to customers, both private and business. The balance responsible party (BRP): They buy the electricity for the supplier and have an obligation to supply the agreed amount per time-unit.
