Foreigners are only subject to PIT if they qualify as tax residents in the country. Are Social Security deductions deductible in Ethiopia? In Ethiopia, social security deductions made by employees are typically deductible when calculating taxable income. This means that the amounts employees contribute to the social security system are subtracted from their gross income before the computation of income tax. Are pension contributions taxable in Ethiopia? Any earnings above this threshold are not subject to pension contributions. This means the employee's 7% and employer's 11% pension contributions are only deducted from up to ETB 15,000 per month, capping total monthly contributions at ETB 2,700.
