Do EPCs need to be provided on sales and lettings? 1. Do EPCs need to be provided on sales and lettings and if so, are there any statutory minimum requirements? Yes, EPCs are mandatory for all sales and lettings of residential or commercial properties in mainland France and must be provided to all potential buyers or tenants. Are green leases required in France? So far, in France, there is no general market practice according to which banks and financing institutions require a borrower to insert specific green lease provisions in their leases when granting loans to borrowers. Are there ESG requirements for new buildings? No, there are no ESG requirements applicable to new or existing buildings. Various recent legal provisions have been introduced with the aim of ensuring energy transition. For instance, to reduce carbon emissions from buildings, the new construction sector must comply with the "RE2020" environmental regulation.
