How does cost of storage affect LCOE? As the fraction of electricity that is directly consumed decreases and the fraction of electricity that is stored beforehand increases, the impact of the cost of storage per energy throughput (also called levelized cost of storage or LCOS) on the LCOE increases. For renewable energy shares above 70%, long term storage is required. What is levelized cost of Storage (LCOS)? The common method for this is to use the levelized cost of storage (LCOS) approach, where a cost is assigned to storing and releasing a defined amount of energy (e.g. one kWh or one MWh) in a certain application without consideration of the actual size of the ESS.
